**If you are in need of Rental Assistance, please see the information below:**

1. **Financial Assistance.** For financial assistance, please call 650.968.0836 or email [RentHelp@csacares.org](mailto:RentHelp@csacares.org) and kindly wait for a call back. We are experiencing a high volume of calls right now for rental assistance; however a CSA staff member will call you back to conduct a rental screening and determine your eligibility.
2. **Determining eligibility.** We strongly recommend that individuals do not *self-select themselves out of this opportunity and always communicate with a CSA staff member for any questions or concerns.* Please be sure to maintain an open communication with your landlord and the assigned CSA staff member at all times. Please be patient with CSA staff, CSA is here to help you.
3. **Mountain View COVID Relief Program.** Starting October 1<sup>st</sup>, 2020 anyone applying for rental assistance because of COVID-19 will need to meet the following criteria to apply: 1) Economic hardship caused by the pandemic (*hours cut, lay-off or loss of childcare*), 2) earn at or below 80% the area median income, and 3) be a Mountain View resident.  
If you have been assisted with your first and second month's rent, we will place you on a waiting list for additional assistance, we will be in touch to review your situation. All assistance will be approved based on funding availability and eligibility. Thank you.
4. **Temporary Moratoriums.** On January 29, the State of California adopted legislation (SB 91) that extends the Tenant, Homeowner, and Small Landlord Relief Act (AB 3088). SB 91's Tenant Relief Act extends eviction protections for tenants experiencing COVID-19 financial hardship effective immediately. Tenants are protected by SB 91; however tenants and landlords must follow, the State's eviction moratorium requirements. It is important that tenants and landlords know that the State law has different noticing and past-due rent repayment requirements than the City's previous law.
